# One Valley, from the frontline to the bargaining table – and to the picket line!

When healthcare workers are outside, something is wrong inside. We can't continue to live with wages that fall behind King County inflation, or sick leave banks that leave us unable to recover when we are sick or need to care for a family member. That's why, after 14 bargaining sessions with management and still no contract to show for it, we raised our picket signs and sent a message to management: That we won't accept less than fair pay and sick leave that matches the standards in other UW Medicine hospitals – why would we deserve less?

Alongside our coworkers, friends, families, community leaders, neighbors, and pets, we stood together, and made our voices heard. We're ready to keep up the fight and stay persistent because we know a strong contract with fair wages and benefits is critical to safe patient care. It's not just about us — it's about upholding the high-quality care our South King County community deserves.

"Because of the strong sick leave policy we won at Harborview, it allows me to stay home when I need to, whether for a mental health day or when I'm physically unwell, without risking the health of my coworkers and patients.
