
Tis the Season to Be Union

HAPPY HOLIDAYS AND HIGHER WAGES!

Because of our unity this year, we won a contract with two wage increases that apply to everyone! All union represented workers at Deaconess and Valley hospitals will see our across-the-board wage increase of 4% this month. This is effective December 1 and will be paid starting on our first check covering the first full pay period in December. We will see this increase on the new 2025 wage scale in our current union contract – available from your union rep or online here:



It's a lump of coal for MHS this year! We're enforcing our win on RBS and 3 hour minimum callback retro



Our last contract was historic, with record wage increases and changes to our call back and rest between shifts language that brought us to community standards. Unfortunately, we've had to fight to enforce these wins. The new rest between shift (RBS) language and three hour minimum callback language was supposed to start on April 7. MHS didn't implement it until July 28. Our grievances and collective action led MHS to agree to retroactive pay, but that pay has been mishandled.

The Training Fund Professional Development benefit has now been expanded to cover reimbursement for State and Federal licenses required for employment, and eligible professional development activities for all bargaining units!

Members can use this benefit to seek reimbursement for any activity/payment from September 1, 2024 onward.

You can now use your \$300/year Professional Development reimbursement benefit to cover State and Federal licenses required for employment.

This also includes annual WA Department of Health License Renewals

You will need to provide:

- Valid proof of payment
 - o (Receipt that includes: Name, Date of payment & Paid activity)
- Copy of your license info that was paid when making this request
 - o (Screenshot directly from the DOH website after renewal is acceptable proof)

Make sure you submit all 2024 funding requests before the Dec 31 deadline.
